TERMS AND CONDITIONS

A. LIABILITY WAIVER AND RELEASE - The student understands and agrees that strict observation of the rules and regulations relative to training, including the use of protective equipment, is required and that the use of facilities and the student’s presence at the school are at the sole risk of the student. It is understood and agreed by the student that martial arts involves defensive and offensive skills and training which include violent and sudden movements and that in connection with the training and instruction sessions there will be physical contact between instructors and students and between and among the students themselves and that such contact may result in personal injury despite the best intentions and following adequate precautions. The student agrees that the school and its instructors, agents, employees, operators, and authorized representatives shall not be responsible for and are hereby released from any liability, claim, loss, including loss of property, damage, personal injury, or expense incurred by a student or anyone claiming through a student, or related to any activity connected with the school including, but not limited to, any caused by the negligence or gross negligence of the school or its instructors, students, agents, employees, operators or authorized representatives.

B. PHYSICAL CONTACT - Student understands that during the course of instruction, instructors of the school and/or other students or authorized person will be engaged in a course of conduct requiring physical contact with the student and he/she gives full consent to such contact as is required by the training program and classes.

C. STUDENT FITNESS - By signing this agreement, the student represents to the school that he/she has had an opportunity to observe the program selected by the student prior to signing this agreement and that he/she is physically and mentally fit to take classes offered by the school in that program or any others selected by the student.

D. ATTENDANCE/NON-USE - Student understands and agrees that student progress requires regular class attendance and that it is the student’s responsibility to attend classes. The failure or inability of the student to use the facilities, classes or services of the school for any reason, will neither relieve nor suspend the student’s obligation to make all payments required under this agreement on a timely basis nor entitle the student to refund or credit of tuition. A student may suspend payment for up to three (3) months in the event of work related absence, vacation or illness.

E. UNAVAILABILITY - If the school or its facilities are substantially unavailable for use due to damage or loss by fire, accident, act of God or any other cause, the student's program will be extended for a period of time equal to the loss of availability, but no refund or credit will be due the student.

F. CLASSES, FACILITIES, AND INSTRUCTORS - Scheduling and content of classes are at the sole discretion of the school and may be changed from time-to-time upon notice by the school. The school agrees to furnish the student with qualified instructors to teach and supervise classes, practice sessions, and contests conducted by the school.

G. SUSPENSION/TERMINATION - The school reserves the right to immediately suspend or terminate any student from participation as a student or enjoyment of the rights under this agreement for failure to comply with the rules and regulations of the school, its facility or students. Suspension or termination of a student shall not entitle the student to a refund or credit for any tuition already paid or cancel any unpaid amount due for tuition. A student may terminate the agreement by exercising a "Buy-Out" option equal to two month's tuition.

H. HOLIDAYS - Classes are not held on national or local holidays recognized by the school.

I. CO-SIGNOR OR PARENT/GUARDIAN - The person(s) signing this agreement as a co-signor or parent or guardian agrees to be jointly, severally, and individually liable as if signing as the student.

J. COMPLIANCE WITH LAWS AND REGULATIONS - All rights and obligations of the school and student under this agreement are subject to applicable federal, state and local laws and regulations. When in conflict of this agreement, the contents of such laws and regulations shall be deemed to expressly modify this agreement and the agreement shall be deemed reworded to incorporate such text as may be necessary in order to make this agreement in compliance therewith. The school and student agree to continue to be bound under the modified agreement including such text and further agree that no other modifications shall be deemed made to the agreement. If any portion of this agreement shall be deemed unenforceable, no other portion shall be unenforceable. Any waiver or delay by the school in enforcing any right under this agreement will not be a waiver or release thereof.

K. ACCEPTANCE OF STUDENT - Upon acceptance as a student at the school, student agrees to faithfully comply with the provisions, terms and conditions hereof, the rules and regulations of the school and traditions of the martial arts.
